(With or without utilities) 2" x 6" (38 mm x 140 mm) minimum. See page 12 and page 13 for plumbing utility locations and dimensions.


#### **Non-Standard Wall Construction**

7-1/2" (191 mm) depth minimum. See page 14 for plumbing utility locations and dimensions.


## **Other Construction Requirements**




## **Utility Placement and Elevation**






## A-dec 541pro/545sta - Plan View




## A-dec 541pro/545sta - Range of Motion




## A-dec 541B/545 - Plan View




## A-dec 541B/541A/545 - Range of Motion




#### Standard Wood Wall Construction, 2" x 6" (38 mm x 140 mm) Minimum

- General wall dimensions are shown for reference only.




#### Standard Wood Wall Construction with Utilities, 2" x 6" (38 mm x 140 mm) Minimum

The starting point for all plumbing utility dimensions are referenced by a spotting target ( ). This marks the intersection of the mounting bracket center line and the front side of the 12 o'clock wall.



#### Non-Standard Wall Construction with Utilities, 7-1/2" (191 mm) Depth Minimum

- The plumbing locations shown within this footprint are specific to metal or other wall construction methods only.
- The finished wall depth is unspecified and must be reviewed and approved by the project design team.



#### **Foot Control Wall Plate**


Position the foot control wall plate in any location on the wall; there is no specific placement relationship with the 541/545 mounting bracket.
